NOTICE OF OPPORTUNITY TO SUBMIT WRITTEN COMMENTS ON PROPOSED RULE

(By Monday, December 7, 2015) and NOTICE OF PROPOSED RULE ADOPTION HEARING (Set for Wednesday, January 6, 2016, at 1:30 p.m.)

RE: Rulemaking to Consider Adoption of Rules Relating to Rail Safety, WAC 480-62

TO ALL INTERESTED PERSONS:

This letter informs you of the progress made in this rulemaking docket concerning the possible adoption of new rules to address rail safety. This letter also provides notice of an opportunity to file written comments on the proposed rules and to participate in the formal rule adoption hearing scheduled for 1:30 p.m., on Wednesday, January 6, 2016.

On May 20, 2015, the Utilities and Transportation Commission (Commission) filed with the Office of the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider adoption of new rules within WAC 480-62. The new rules update railroad annual reporting requirements on financial responsibility and safety standards for private crossings and to provide opportunities for first-class cities to opt in to the Commission crossing safety program. The Commission filed the CR-101 under Docket TR-151079.

On May 22, 2015, prior to drafting any revised rule language the Commission issued a notice of opportunity to file written comment to questions posed by the Commission on:

- 1. What is your definition of a reasonably likely worst-case spill of oil?
- 2. What is a reasonable per-barrel cleanup and damage cost of spilled oil?
- 3. What risk factors should the Commission consider in establishing safety standards on private crossings?

Comments were due on June 22, 2015, and the Commission accepted additional comments during a workshop held on July 8, 2015.

On August 21, 2015, the Commission published informal draft rule language relating to chapter 480-62-130, 480-62-260, 480-62-270 and 480-62-300 WAC and issued a notice requesting responses on the informal draft revisions. Comments were due on September 21, 2015.

A summary of the comments submitted is available on the Commission's website. All documents submitted to, or issued by, the Commission in this matter are available on the Commission's website located at: www.utc.wa.gov/151079.

On November 4, 2015, the Commission filed a Notice of Proposed Rulemaking (CR-102) with the Office of the Code Reviser. The Commission has reviewed comments from stakeholders received to date in this docket and has prepared proposed rules for review and comment by interested persons.

The proposed rules are available for inspection on the Commission's website at www.utc.wa.gov/151079. The CR-102 filing initiates the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
