Re: In the Matter of the Petition of PacifiCorp, d/b/a Pacific Power & Light Company Co., 2022 Power Cost Adjustment Mechanism Annual Report, Docket UE-230482.

Dear Mr. Killip,

PacifiCorp, d/b/a Pacific Power & Light Company (PacifiCorp or the Company) submits this errata to PacifiCorp's Post-Hearing Brief to update the citation to the record in footnote 46 on page 9.

As background, both the Alliance of Western Energy Consumers (AWEC) and PacifiCorp included witness Bradley G. Mullins' testimony from Wyoming Public Service Commission Docket No. 20000-642-EM-23 as cross-examination exhibits in this docket (*see* Exhibit DRS-15CX and Exhibit BGM-13CX). However, PacifiCorp's Exhibit BGM-13CX was comprehensive and included all the exhibits that accompanied witness Mullins' Wyoming testimony, while AWEC's Exhibit DRS-15CX included only the narrative testimony.

When discussing witness Mullins' inconsistent Wyoming testimony, PacifiCorp's Post-Hearing Brief cited AWEC's cross-examination exhibit rather than the comprehensive version that PacifiCorp filed. In response, AWEC's Reply Brief argued that the inconsistency noted by PacifiCorp was apparent only in the exhibits that accompanied witness Mullins' Wyoming testimony, which AWEC incorrectly argued were not admitted into the record. *See* AWEC Reply Brief at 5, footnote 14 ("Mr. Mullins summarized his [Wyoming] analysis in his testimony, which was included as a cross-examination exhibit in the record, but his full analysis was provided in a separate exhibit, which was not admitted to the record. Exh. DRS-15CX at 40:11-23. Therefore, there is nothing in the record to support PacifiCorp's statement . . ."). In fact, Exhibit BGM-13CX includes the "full analysis" from witness Mullins' Wyoming testimony and was admitted into the record. This errata updates the citation in PacifiCorp's Post-Hearing Brief to Exhibit BGM-13CX to clarify that PacifiCorp's argument in its Post-Hearing Brief is supported by evidence in the record.
