In accordance with the Commission's Order 12 in Docket UG-210755, Cascade Natural Gas Corporation (Cascade) submits Protected Plus Excess Deferred Income Tax (EDIT) filing which proposes changes to the following tariff sheets effective March 1, 2023:

This filing incorporates into base rates the PP EDIT associated with the test year in the Company's general rate case in Docket UG-210755. The result to base rates is a reduction in revenue requirement of \$1,722,239. The filing also eliminates Rate Schedule 581 which was used to pass PP EDIT credits to customers. This component of the filing increases revenues by \$1,971,691. The net impact of the filing is an increase in revenues of \$249,452.

This filing represents a net overall increase in revenue of \$249,452. An average residential customer using 54 therms per month will see a bill increase of \$0.03 per month or 0.04 percent.
