Re: *Washington Utilities and Transportation Commission v. Burton Water Company, Inc.*, Dockets UW-091050 and UW-091051 (*Consolidated*)

TO ALL PARTIES:

The Washington Utilities and Transportation Commission (Commission) issued a notice of finality on January 14, 2010, allowing a consolidated initial order entered on January 8, 2010, in these proceedings to become effective by operation of law: Order 03, Initial Order Approving Tariff Filings; Approving and Adopting Settlement Stipulation; Requiring Compliance Filing in Docket UW-091050, and Initial Order Rejecting Tariff Filings; Approving and Adopting Settlement Stipulation; Requiring Compliance Filing in Docket UW-091051. The consolidated order, among other things, authorized and required Burton Water Company, Inc. (Burton Water) to file tariff sheets consistent with the terms of the Order. The Order also authorized the Commission's Secretary to approve the filing by letter if the company complied with the terms of the Order.

On January 12, 2010, Burton Water filed tariff sheets as specified in the Order. On January 15, 2009, Burton Water filed replacement tariff pages in compliance with the Order. A list of these tariff sheets is attached to this letter. Commission Staff has examined these filings and concluded that the new and revised tariff sheets appear to comply with the terms of the Order.

Therefore, pursuant to the terms of the Initial Order 03 in this proceeding, which became effective on January 14, 2010, the tariff sheets indicated on the attachment to this letter will become effective as filed with an effective date of February 1, 2010.
