DECLARATION OF STEVE YOUNG IN SUPPORT OF SALMON SHORES' MOTION FOR REMOVING SALMON SHORES RV PARK AS A RESPONDENT

STEVE YOUNG states as follows:

- I am the owner of Salmon Shores RV Park. I have personal knowledge of the statements set forth in this declaration. I make this declaration in support of Salmon Shores' Motion for Summary Determination.
- 2. Mr. Binkley is a tenant of Salmon Shores. Salmon Shores RV Park, LLC ("Salmon Shores") is a customer of PSE.
- 3. Salmon Shores is a private recreational vehicle park that rents individual sites for tent camping, and seasonal and month to month recreational vehicle ("RV") sites with utility hookups. Mr. Binkley is a month to month recreational vehicle tenant.

- 4. PSE serves Salmon Shores with six electric meters. Salmon Shores provides electric service from the PSE meters to various facilities in the park including to each RV site. Each RV site is separately metered. Salmon Shores also provides the electrical meters for its office and store on the premises. Salmon Shores uses the electricity provided by PSE for itself and its tenants. Salmon Shores bills its tenants for electricity provided to Salmon Shores by PSE. Salmon Shores also charges an Electrical Access Charge ("EAC") to recover its reasonable costs for billing and collecting for electricity usage by its tenants.
- 5. Salmon Shores does not provide electrical service outside the boundaries of its property or to any persons other than those renting sites in the park or using the park facilities.
- 6. I declare under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct to the best of my knowledge.
