Dear Mr. King:

Cascade Natural Gas Corporation ("Cascade") requests that the enclosed Errata – page 11 of Cascade Natural Gas Corporation's Reply to NWIGU and Public Counsel Answer and Objection to Petition of Cascade Natural Gas Corporation for a Motion for Waiver and to the Energy Project's Answer and Objection to Cascade Natural Gas Petition for Waiver ("Reply") – be substituted for page 11 of Cascade's Reply filed on July 16, 2015.

Cascade mistakenly left out a "not" in paragraph 21, which reversed the intended meaning of the sentence. The corrected sentence should read:

Cascade's overall request to increase rates by 1.59% that when equally applied to all customer classes results in a 6.28% increase to transportation customers does <u>not</u> trigger a GRC.
