DECLARATION OF RACHEL JONES

Rachel Jones, under penalty of perjury under the laws of the State of Washington, declares as follows:

- 1. I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Consumer Protection Section. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility and transportation companies. As part of those duties, I investigate household goods carriers that may be operating without the required Commission permit.
- 2. On January 11, 2017, commission staff received an email tip that Moves for Seniors/Transit Systems, Inc. is possibly operating as a household goods carrier within Washington state without having the proper permit with Utilities and Transportation Commission.
- 3. On January 12, 2017, I conducted a Google search for Moves for Seniors and Transit Systems, Inc. The results produced advertisements on <a href="https://www.holidayretirement.com">www.holidayretirement.com</a>, <a href="https://www.holidayreti
- 4. On January 12, 2017, a search on Better Business Bureau database produced no results for Moves for Seniors but had a result for Transit Systems, Inc.<sup>2</sup>
- 5. On January 30, 2017, a search of Department of Revenue's database produced no records for Moves for Seniors.<sup>3</sup>

- 6. On January 30, 2017, a search of Washington Secretary of State Corporations Registration database produced no records for Moves for Seniors.<sup>4</sup>
- 7. On January 30, 2017, a search of Department of Licensing's database produced no records for Moves for Seniors.<sup>5</sup>
- 8. On January 30, 2017, a search of the U.S. Department of Transportation's Safety and Fitness Electronic Records (SAFER) produced no records for Moves for Seniors.<sup>6</sup>
- 9. On January 30, 2017, a search of Commission records produced no record of Moves for Seniors as being a permitted household goods carrier with the Commission.<sup>7</sup>
- 10. On February 3, 2017, a compliance letter was sent to Tara Chila requesting her to cease and desist as a household goods carrier in Washington state, until a household goods permit is issued from the Commission.<sup>8</sup>
- 11. On May 5, 2017, I requested a moving quote on www.movesforseniors.com.9
- 12. On May 8, 2017, I received an email from Susan Obsobrne from the email address <a href="mailto:susano@movesforseniors.com">susano@movesforseniors.com</a>. The email stated that I would be charged \$638 for a four hour move and the price includes two men, truck, and travel fee. 10

RE: Household Goods Moving in Washington State

Dear Ms. Chila:

To avoid enforcement action, your complete household goods permit application, supporting materials, and application fee must be submitted to the commission by Feb. 17, 2017.

Until you obtain a permit, you must immediately <u>cease operating</u> as a household goods mover in Washington State. Operating as a household goods mover without the required permit is illegal and subject to a penalty of \$5,000 per violation. This means that you may receive this penalty for each day you operate in violation of the law.

You must also immediately <u>cease advertising</u> as a household goods mover in Washington State. Advertising for the transportation of property for compensation in Washington without a proper permit is against the law. The penalty for advertising without a permit is \$5,000 per violation. This means that you may receive a penalty for each and every advertisement. At this time, the commission has documented advertisements for household goods moving services from Moves for Seniors.

If you advertise or operate as a household goods mover without a permit, the commission will take enforcement action against you. Such action may include the above-mentioned financial penalties; and you will be served with a subpoena and be required to appear before a judge.

Again, to avoid enforcement action, your complete application, supporting materials, and application fee must be submitted to the commission by Feb. 17, 2017.


Should you decide to apply for a household goods moving permit, please note that you still may not operate as a household goods mover in Washington State until you have received a permit. 
