Dear David:

This letter will document our organizations' decisions regarding the contractual service agreements between GENERAL ELECTRIC INTERNATIONAL, INC ("GE") and PUGET SOUND ENERGY, INC. ("PSE") at both Mint Farm ("REVISED AND RESTATED LONG TERM SERVICE AGREEMENT BETWEEN MINT FARM GENERATION AND GENERAL ELECTRIC INTERNATIONAL, INC. dated December 14, 2015") and Goldendale ("REVISED AND RESTATED CONTRACTUAL SERVICE AGREEMENT BETWEEN PUGET SOUND ENERGY, INC. AND GENERAL ELECTRIC INTERNATIONAL, INC. dated December 14, 2015") (collectively "Agreement"). GE agrees to change the Factored Fired Hour outage intervals from 24,000 to 32,000 Factored Fired Hour outage intervals per Section 2.9.

In conjunction with this modification of outage intervals, GE will modify the Variable Monthly Fee as defined in Section 5.2.2 of the Agreement from the current, REDACTED VERSION. This change in fee is intended to share in the benefit of extending outage intervals with PSE. This new Variable Monthly Fee will be effective as of Oct 1<sup>st</sup>, 2017.

Further, if the Agreement(s) expire by reaching the 22<sup>nd</sup> anniversary of the Contract Effective Date before reaching the Performance End Date, PSE will not owe GE any payments related to the Shortfall payments as defined in Section 5.11.

This letter documents GE and PSE's agreement. Please sign this letter and return to GE. This offer is valid till 12 pm Pacific Time on September 29<sup>th</sup>, 2017. Both parties agree that this letter, once executed, will constitute amendment 1 to the Agreement.


