QWEST'S UNOPPOSED MOTION TO  
EXTEND DATE TO FILE RESPONSES TO  
PETITIONS FOR REVIEW


1. Qwest Corporation ("Qwest"), pursuant to the rules of the Washington Utilities and Transportation Commission ("the Commission"), requests that the current filing date for Responses to Petitions for Review filed on Thursday, October 24, 2007 be extended from Monday, November 5, 2007 to Wednesday, November 14, 2007 for electronic filing and Thursday, November 15, 2007 for filing of paper copies. The grounds for this motion are as follows:
2. Petitions for Review were filed by Broadwing, Level 3, WITA, ELI/Advanced Telcom, and Pac West on October 24, 2007. In the aggregate, these Petitions for Review raise

numerous issues that will require significant effort to respond to. A short extension would allow the parties adequate time to respond in full to the Petitions for Review.

3. On Friday, October 26, 2007, Qwest communicated with all parties in this matter suggesting a short extension in the time to file responses to Petitions for Review.
4. At this point, all parties that filed Petitions for Review (and Staff and TCG as well) have, via email, indicated agreement to an extension to Wednesday, November 14, 2007. In addition, Mr. Kopta, on behalf of his clients, suggested that "[m]y clients have no objection to an extension but would appreciate the ability to file electronically on whatever date during the week of November 12, 2007 we decide on (realizing that the Commission will consider the actual deadline to be the day afterwards)."
5. Therefore, all parties are in agreement that electronic filing of Responses to Petitions for Review would be made on November 14, 2007, with filing of the necessary paper copies on Thursday, November 15, 2007.
6. In light of the agreement of the parties, Qwest requests that an order reflecting the foregoing be issued in this matter.
