This quarterly progress report provides information required by Section 4, Paragraph 4.1, of Appendix B of the Administrative Settlement Agreement and Order on Consent for Removal Action (Order) Amendment No. 2 for actions taken from June 1, 2020, through August 31, 2020, at the Navigation Channel Project Area within the Portland Harbor Superfund Site.

1. Actions and Correspondences That Occurred in This Quarter

The following actions and correspondences occurred in this quarter:

- June 5 Anchor QEA submitted the *Pre-Design Investigation Work Plan*.
- June 15 Anchor QEA submitted the quarterly progress report for the period March 4, 2020, through May 31, 2020.
- June 16 NW Natural received confirmation from EPA that the content of the quarterly progress report meets EPA's expectations.
- June 17 NW Natural received EPA's comments on the Pre-Design Investigation Work Plan.
- June 24 Anchor QEA submitted the Sufficiency Assessment.
- July 14 Anchor QEA submitted the *Revised Pre-Design Investigation Work Plan* and associated responses to EPA's comments.
- July 28 NW Natural received EPA's comments on the Sufficiency Assessment.
- August 4 NW Natural received EPA's conditional approval of the Revised Pre-Design Investigation Work Plan.
- August 10 Anchor QEA submitted the Revised Final Pre-Design Investigation Work Plan and associated responses to EPA's conditional approval requirements.
- August 14 NW Natural received EPA's final approval of the Revised Final Pre-Design Investigation Work Plan.

August 19 – Submitted the Application for Short-Term Access Agreement to the Oregon State
Department of State Licensing (DSL) for completion of the EPA-approved pre-design
investigation sampling within the Navigation Channel Project Area.

2. Results of Sampling, Tests, and Other Data Received

No results of sampling, tests, or other data were received during this quarter.

3. Schedule of Activities for the Next Quarter

The following activities are scheduled to occur in the next quarter:

- Submit a Revised Sufficiency Assessment that addresses EPA's comments.
- Complete the pre-design investigation field sampling in accordance with the EPA-approved Revised Final Pre-Design Investigation Work Plan.
- Receipt of executed Short-Term Access Agreement from DSL.

4. Challenges and Proposed Resolutions

No unresolved delays were encountered or are anticipated in the next quarter that may affect the future schedule for implementation of the scope of work. As of the date of this report, data collection has been suspended for several days due to hazardous air conditions associated with regional wildfires. We do not presently believe this suspension will materially affect the overall schedule.

5. Modifications to Work Plans or Schedules

No modifications were proposed or are anticipated in the next quarter.

6. Activities in Support of Community Involvement Plan

EPA has not requested any community involvement plan support from NW Natural.
