Staff has reviewed the comments submitted and is looking forward to the workshop to discuss the draft amendments and the comments received. Staff has made changes to the original draft amendments in an attempt to at least partially address the comments. Some of the comments require additional research or further discussion at the workshop, and so are not reflected in the changes to the draft amendments.

Attached for your information is the agenda for the workshop, a summary of the comments received with Staff's responses, and a new version of the draft amendments. The changes in the draft amendments are shown in **bold print using blue font color**. Added language is underlined and language that would be deleted is struck through.

The document showing the changes also include some stylistic changes to conform with the format requirements of the Code Reviser's Office, which publishes proposed and adopted rules. These do not change the meaning of the rules, so I have not highlighted them.
