TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) will accept comments on PacifiCorp d/b/a Pacific Power & Light Company's (PacifiCorp or Company) Final 2021 Integrated Resource Plan for electric service (Final IRP). Per [WAC 480-100-605](#), an "integrated resource plan" (IRP or Plan) means an analysis describing the mix of generating resources, conservation, methods, technologies, and resources to integrate renewable resources and, where applicable, address overgeneration events, and efficiency resources that will meet current and projected needs at the lowest reasonable cost to the utility and its ratepayers and that complies with the requirements specified in [RCW 19.280.030](#)(1).

A copy of the IRP can be accessed via [PacifiCorp's electronic docket](#), available online through the Commission's Record Center. Requests for copies of the Plan should be directed to PacifiCorp.

**WRITTEN COMMENTS**

Written comments on the Plan must be filed with the Commission no later than **5:00 p.m. on October 4, 2021**.
