THE TRANSPORTATION NEED Briefly describe the transportation service that you need and that the application could provide to you or your business/organization if this request for operating authority is granted.

I am the owner and operator of Gato Verde Adventure Sailing School LLC. The business has been operating out of Bellingham since 2004. I and my customers have periodic need for foot ferry service between Bellingham and the surrounding islands. There has been minimal foot service out of Bellingham for many years. Summer 2010, Island Commuter stopped the Memorial Day- Labor Day regular, tourist oriented, service between Bellingham and San Juan Island with flag stops changing to weekends & holidays only. In 2011 they decreased service further to just 9 days per year forcing all foot traffic through Anacortes via the state ferries and water taxi's. Bellingham is long overdue for simple, regular, year-round foot ferry service and the companies with the vessels and permits are not providing that service.

Captain McNamara operated a viable water taxi out of Bellingham for many years. He had a loyal customer base and I believe he understands the market and will be able to provide the services requested in this permit.

Are your transportation needs being met now? Yes ___ No X If not, explain problems you have experienced.

There is no regularly scheduled foot ferry service available out of Bellingham for small groups or individuals. Because of this it can take over 8 hours for someone to get from San Juan Island to Bellingham without a car.

If the request is denied, would it have any affect on you or your business/organization: Yes X No ___ If yes, please explain.

If the request was denied it would limit my customer's options for travel within the islands. By granting the request, my customers (and myself) would have much greater flexibility for transportation within the islands. A greater benefit of granting this application would be for Bellingham and the Islands. It would provide reasonably priced regular year-round service that has not been available for many years. I also do not think granting this application would have a major negative impact on the existing permit holders business since they have chosen to cut back their service so dramatically.
