PETITION TO INTERVENE

14 **COMES NOW** the Washington Refuse and Recycling Association (WRRRA)  
15 and respectfully petitions to intervene in the above matter pursuant to WAC  
16 480-07-355, and in doing so alleges as follows:

17 1) Proposed intervenor's address is: 4160 - 6<sup>th</sup> Ave. SE, Suite 205,  
18 Lacey, Washington 98503.

19 2) WRRRA is a trade association representing the vast majority of solid  
20 waste haulers in Washington state. As such, it has taken part as a party,  
21 intervenor or interested party in virtually every WUTC hearing regarding solid  
22 waste since the inception of regulation of solid waste. Matters involving  
23 regulation of the solid waste industry are of interest to the members of WRRRA,  
24 who would not be parties in this action. The issues presented in this action are  
25 of substantial interest to the solid waste industry in Washington in general, and  
26 to all individual G-certificate holders who are members of WRRRA.

1           3)     A trade association such as WRRRA is included in the definition of  
2 "person" in WAC 480-07-340(1)(a). WAC 480-07-355(1)(a) provides that "any  
3 person" may file a Petition to Intervene.

4           4)     WRRRA's participation as an intervenor in this action will not broaden  
5 the issues in the matter. WRRRA does not intend to call any witnesses at hearing,  
6 but reserves the right to do so should issues brought by the primary parties  
7 result in the presentation of witnesses by WRRRA being helpful to the  
8 Commission;


9           5)     WRRRA's position in this action is expected to be in support of the


