DECLARATION OF SUZANNE STILLWELL

I. BACKGROUND

- I, Suzanne Stillwell, under penalty of perjury under the laws of the State of Washington, declares as follows:
 - 1. I am employed by the Washington Utilities and Transportation Commission
 (Commission) as Licensing Services Manager in the Safety and Consumer
 Protection Division. One of my responsibilities includes overseeing staff who
 process applications. One of the steps is to check with Financial Services to see if
 there are any outstanding penalties owing from new applicants or applicants
 requesting reinstatement. I will occasionally perform this task and did so
 regarding this applicant.

- 2. The Commission received a proposed agreement for reinstatement and supporting documentation from Sani M. Maurou on behalf of SeaTac Airport 24 ("Company") on April 19, 2016, in consolidated dockets TC-152296 and TC-160187. Included with the proposed payment plan was a receipt showing payment of \$340.00 on April 6, 2016, to AllianceOne Receivables Management, Inc. ("Collections"), the collections agency for the Company.
- On April 19, 2016, I was included in an email conversation wherein Staff attempted to verify with Collections that the Company had made the \$340.00 payment towards the amount owed.
- 4. By April 20, 2016, Collections had confirmed that the Company had not made any payment on the amount owed to the Commission. Collections advised that the Company had made a payment of \$340.00, but that this amount was applied to other accounts at Collections and not to the amount owed to the Commission.
- 5. A true and accurate copy of the email conversation with Collections regarding this matter is attached to this declaration as Attachment A.
