Description of amendment:

This amendment deletes certain UNEs and/or changes or adds terms and conditions for certain UNEs as set forth in Attachment 1 and Exhibit A, attached to this amendment.

The amendment amends the interconnection agreement first accepted by the Commission on 3/10/99 (date) in WUTC Docket No. UT-990313 (current docket number). That agreement was originally approved by the Commission on 4/23/97 (date) in WUTC Docket No. UT-960337 (original docket number) between U.S. West Communications, Inc. and Electric Lightwave, Inc. (Name of company C).

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
