TO ALL PARTIES:

On February 10, 2022, Beeline Tours LTD d/b/a Seattle Express (Beeline) filed with the Washington Utilities and Transportation Commission (Commission) an application for an extension of its existing Bus Certificate (Application). On February 15, 2022, the Commission served a Notice of the Application on its list of persons requesting such notification.

On March 16, 2022, Pacific Northwest Transportation Services, Inc., d/b/a Premier Airport Shuttle/Capital Aeroporter (PAS-CA) filed a protest to the Application.

On March 22, 2022, the Commission issued a Notice of Brief Adjudicative Proceeding (BAP); Setting Time for Oral Statements (BAP Notice), which set time for oral statements on April 21, 2022, at 9:30 a.m. A copy of the BAP Notice is enclosed as Attachment A and incorporated into this notice by reference.

On April 19, 2022, PAS-CA contacted the presiding officer to inform the Commission that PAS-CA had not received service of the BAP Notice sufficiently in advance of the hearing date as required by 480-07-610(5)(a) and requested that the Commission reschedule the BAP.

Because the Commission did not serve the BAP Notice on PAS-CA, the Commission finds good cause to reschedule the virtual BAP for May 4, 2022, at 9:30 a.m. To attend by phone, call (253) 215-8782 and enter the Meeting ID: 989 6819 5676# and Passcode: 969712#. The Commission adheres to the requirements set forth in the BAP Notice with respect to how the Commission will conduct the proceeding. The parties have previously submitted and exhibit list and proposed exhibits and need not resubmit them. Parties wishing to submit any other documents for consideration at the brief adjudicative proceeding must file with the Commission a supplemental exhibit list enumerating and describing any such documents no later than 5 p.m. on Friday, April 29, 2022, and email copies of such documents to the presiding officer. On that same date, each party must identify the person who will be making the oral statement on behalf of that party. Filing must be in accordance with WAC 480-07-140.

As originally contemplated, the presiding officer does not intend to permit the testimony of witnesses at the BAP (other than the person making the oral statement on behalf of each party). Either party may file a request to present the testimony of one or more witnesses at the BAP no later than 5 p.m. on Tuesday, April 26, 2022. Such a request must include an explanation of why such testimony is necessary to provide the Commission with the facts it needs to make a determination in this docket. The request must also identify each witness the party proposes to have testify and provide a brief summary of that witness's proposed testimony. The other party may file a response to that request no later than 5 p.m. on Friday, April 29, 2022. The presiding officer will render a decision on the request prior to the BAP.

THE COMMISSION GIVES NOTICE That the brief adjudicative proceeding in Docket TC-220090 is rescheduled to Wednesday, May 4, 2022, beginning at 9:30 a.m.
