Enclosed for filing in the above-referenced dockets, please find the original and eighteen (18) copies of the Errata Pages for the Responsive Testimony and Exhibits of Robert R. Stephens on behalf of Boise White Paper, L.L.C. (“Boise”). Boise is submitting the revised pages of Mr. Stephens’ Responsive Testimony in both redline/highlighted and clean formats, with the pages marked as “REVISED 11/4/2014.” Similarly, the revised pages of Mr. Stephens’ Responsive Exhibits are submitted in both redline and clean formats, with all pages marked as “REVISED 11/4/2014.”

This filing corrects certain scrivener’s errors and calculation errors attributable to cost of service models which were inadvertently not updated in Mr. Stephens’ workpapers. Boise was made aware of these errors when preparing a response to a data request from the Company; specifically, Mr. Stephens realized that his workpapers had not been updated to reflect a 4 coincident peak (“CP”) allocator using two summer and two winter months, as proposed in testimony. Consequently, certain calculations associated with Boise’s proposed 4 CP allocator were found to be in error in the following:

- Exhibit No. __ (RRS-1T): page 17, Figure 2; page 20, Table 3, “4 CP” column; page 28, Table 5, “Exhibit No. __ (RRS-5)” and “Exhibit No. __ (RRS-8)” columns; and page 28, line 4, “rate of return index”;
- Exhibit No. __ (RRS-4);
- Exhibit No. __ (RRS-5);

- Exhibit No. __ (RRS-6); and
- Exhibit No. __ (RRS-8).

These corrections do not involve any substantive changes to Mr. Stephens' testimony or exhibits, or alter the recommended adjustments of other Boise witnesses in any way. Boise is also submitting the correctly updated workpapers of Mr. Stephens to all parties to this proceeding.


