NOTICE AMENDING PROCEDURAL SCHEDULE

RE: In the Matter of the Petition of Avista Corporation d/b/a Avista Utilities for an Order Authorizing the company to Revise its Electric and Natural Gas Book Depreciation Rates and Authorizing Deferred Accounting Treatment for the difference in Depreciation Expense, Dockets UE-180167 and UG-180168 (Consolidated)

TO ALL PARTIES:

On February 22, 2018, Avista Corporation d/b/a Avista Utilities (Avista or Company) filed with the Washington Utilities and Transportation Commission (Commission) a petition requesting approval of a proposed change to its electric book depreciation rates and authorizing deferred accounting treatment for the difference in depreciation expense (Docket UE-180167). Avista also filed with the Commission a petition requesting approval of a proposed change to its natural gas book depreciation rates and authorizing deferred accounting treatment for the difference in depreciation expense (Docket UG-180168) (collectively, Petitions). On August 22, 2018, Avista filed amended petitions in both dockets, withdrawing its request that the difference between depreciation expense under current book depreciation rates and depreciation expense under the updated depreciation rates be deferred.

On December 12, 2018, the Commission convened a prehearing conference in this Docket, and on December 13, 2018, entered Order 01, Order of Consolidation; Prehearing Conference Order; Notice of Hearing (Order 01). Order 01 adopted a procedural schedule that had been agreed upon at the prehearing conference.

On December 14, 2018, Commission staff (Staff) filed a letter offering an amended agreed procedural schedule, with corrections as follows:
