SCHEDULE 1 GENERAL SALES SERVICE

AVAILABLE:

In all territory served by the Company under the ~~Tariff~~ of which this schedule is a part. To all Customer classes in all territory served by the Company under the ~~Tariff~~ of which this schedule is a part, except that service under this schedule is not available to Non-Residential Customers that use equipment for space heating, protection of equipment or commodities during cold weather, or for Standby purposes. A Customer that initiates a seasonal or temporary Discontinuance of Service shall pay restoration charges set forth in **SCHEDULE C**. New service installations for equipment served under this schedule are subject to the provisions of **SCHEDULE E**.

APPLICABLE:

SERVICE DESCRIPTION:

To firm sales service to all customer classes, where gas is used for the sole purpose of supplying equipment which has been determined by the Company to carry low or **intermittent loads**, including but not limited to one or any multiple or combination of the following: Service under this schedule is Firm Sales Service to gas-fired equipment determined by the Company to have small or Intermittent loads, including but not limited to one or any multiple or combination of the following:

- (a) Non-ducted space heating equipment, including but not limited to fireplace inserts, free standing gas stoves, and room heaters;
- (b) Supplemental or Standby space heating equipment used in residential applications, including but not limited to Natural Gas back-up to electric heat pumps, including but not limited to natural gas back-up to electric heat pumps, used in residential applications;
- (c) non-essential Water heating equipment including but not limited to equipment used to serve single-family residential swimming pools, spas, and hot tubs; and detached shops
- (d) Other equipment including, but not limited to, log lighter, gas log, gas barbecue, tiki torch, Bunsen burner, Domestic cooking equipment, hobby kilns, refrigeration or Domestic clothes drying;
- (e) Equipment installed for use in detached garages, shops, or outbuildings.

Service will not be furnished under this schedule to equipment of commercial and industrial customers that is used for space heating, protection of equipment or commodities during cold weather, or for standby purposes.
