JOINT PROPOSAL FOR PAYMENT PLAN

## I. BACKGROUND

On June 11, 2018, the Washington Utilities and Transportation Commission ("Commission") entered Order 04 in Docket TV-170293 (*Consolidated*), In the Matter of the Penalty Assessment Against Can't Stop Moving, LLC ("Can't Stop Moving" or the "Company") In the Amount of \$51,900, Order 02 in Docket TV-180319 (*Consolidated*), In the Matter of the Investigation of Can't Stop Moving, LLC For Compliance with WAC 480-15-560 and WAC 480-15-570 ("Order 04").

In Order 04, the Commission ordered that the suspended penalty amount of \$15,400 from Order 01 was due and payable. The Commission also ordered the assessment of a new \$28,600 penalty against the Company. The Commission ordered that the Company could request the Commission's approval of a joint proposed payment plan for these amounts. The Company approached Commission Staff ("Staff") and requested to pay these penalty amounts through a payment plan. Staff supports the Company's request. Now, the Company and Staff present a joint proposed payment plan for the payment of these amounts as well as the payment of the remainder of the existing payment plan approved by the Commission in Order 02. The Company and Staff request that the Commission approve this plan, which will combine all penalty amounts owed by the Company and replace the existing payment plan approved by the Commission in Order 02.

## II. PAYMENT PLAN

The Company requested paying the penalty amounts in 36 monthly installments. Staff supports the Company's request. Each monthly payment will total \$1,350, except the last. The first eight installments will be divided between fulfilling the remaining balance of the payment plan approved by the Commission in Order 02 - \$500 per installment – and the penalty amounts imposed and assessed against the Company in Order 04 - \$850 per installment. Beginning with the ninth installment, the Company will continue to pay a total of \$1,350 in each installment. The entirety of the installment payments, beginning with the ninth, will go towards the penalty amounts imposed and assessed and assessed in Order 04. If no more than \$1,350 is paid each month, a final installment of \$750 will be required on June 15, 2021.

Please see the Company and Staff's Proposed Installment Schedule, below, which specifies the deadline for each monthly installment and specifies how the installments are to be divided between the penalties imposed and assessed by Order 04 and the remaining balance of the payment plan approved by the Commission in Order 02.
