- 1. Pursuant to WAC 480-07-375, 480-07-385, and 480-120-875(5)(c), Pac-West Telecomm, Inc. ("Pac-West") requests that the current filing date for Replies to Answers to Petitions for Review filed on Wednesday, November 14, 2007 be extended from Wednesday November 21, 2007 to Friday, November 30, 2007 for electronic filing and Monday, December 3, 2007 for filing of paper copies. The grounds for this motion are as follows:
- 2. Petitions for Review of the Initial Order were filed by Broadwing, Level 3, WITA, ELI/Advanced TelCom, and Pac West on October 24, 2007. These parties, as well as Qwest and Commission Staff, filed Answers to those Petitions on Wednesday, November 14, 2007. While Pac-West continues to analyze all Answers its Petition, Staff's Answer includes several requests to modify the Initial Order to which Pac-West intends to respond as a matter of right under WAC 480-07-825(5)(a). Particularly in light of the upcoming Thanksgiving holiday and the corresponding unavailability of counsel for Pac-West, a short extension of the five day reply period in WAC 480-07-825(5)(c) would enable Pac-West and other interested parties adequate time to review, analyze, and reply as authorized and appropriate to the Answers to the Petitions for Review.

3. On Thursday, November 15, 2007, Pac-West communicated with all parties in this matter suggesting a short extension in the time to file replies to Answers to Petitions for Review. Counsel for Qwest, Staff, Broadwing, Level 3, and ELI/Advanced TelCom have, via email, indicated no objection to Pac-West's request. The remaining parties have not yet responded, but in the interest of prompt consideration of Pac-West's request prior to the existing filing deadline, Pac-West is filing this motion before receiving responses from these parties.

4. Pac-West, therefore, requests that the Commission issue an order granting Pac-West's request and establishing the dates for filing replies to Answers to Petitions for Review as Friday, November 30, 2007 for electronic filing and Monday, December 3, 2007 for filing of paper copies.
