COMMISSION STAFF'S COMMENTS REGARDING NOTICE OF INTENT TO CONDUCT ADDITIONAL PROCESS

## I. INTRODUCTION

Staff of the Washington Utilities and Transportation Commission (Commission) submits the following comments in response to the Commission's Notice of Intent to Conduct Additional Process. In short, Commission Staff (Staff) proposes that the Commission receive additional testimony into the record and extend the deadline for its decision.

## II. BACKGROUND

On July 11, 2018, the entire board of directors of Hydro One Limited (Hydro One) resigned pursuant to an agreement reached with Hydro One's largest shareholder, the Province of Ontario (Ontario). In addition, Hydro One's CEO, Mayo Schmidt, retired. Hydro One has committed to having a new board in place by August 15, 2018, and the new board will select a new CEO. In the interim, Hydro One's CFO, Paul Dobson, is serving as acting CEO. <sup>2</sup>

According to news accounts, the impetus for this change is the election of Ontario Premier Doug Ford. Mr. Ford was elected Premier June 7, 2018.<sup>3</sup> During his campaign, Mr. Ford promised to oust Hydro One's CEO.<sup>4</sup>

## III. DISCUSSION AND PROPOSAL

Staff has entered into a settlement agreement with Hydro One and Avista Corporation (the applicants) and all of the other parties in this docket. Staff supports the settlement and believes that the parties have negotiated a strong foundation of protections for Avista Corporation (Avista) that insulate it from Hydro One. Given the recent changes at Hydro One, however, Staff believes that the record could benefit from further discussion of the protections set forth in the settlement agreement that the applicants have committed to and from testimony by Hydro One's new CEO confirming his or her support of the applicants' commitments.

Under RCW 80.12.030, the Commission has eleven months to render a decision in a transfer of property proceeding; however, this can be extended up to four months for cause. The transfer of property application in this docket was filed September 14, 2017. Eleven months from the filing date is August 14, 2018. It is unlikely that Hydro One will have a new board and CEO in place in sufficient time for the Commission to complete additional process by August 14, especially as Hydro One may not have formed a new board until August 15. Staff believes that the departure of the entire board along with the CEO of Hydro One is cause for the Commission to extend the deadline for its decision in order to conduct additional process.

  One's leadership, once a new CEO has been selected by the new board. In addition, at this
  hearing, the parties can provide additional detail as needed regarding the protections for
  Avista in the commitments that the applicants have made.
