On January 3, 2000, Lights Camera News/Corporate Feud, filed a complaint against U S WEST Communications, Inc. in Docket No. UT-000014. The complaint alleges that the respondent has violated state laws by unlawfully disconnecting complainants telecommunications service, breaching its contract with complainant, and failing to provide prompt, efficient, or adequate service to the complainant. The complainant prays for imposition of sanctions or fines, damages, and refund of various billings from the respondent.

On January 18, 2000, Lights Camera News/Corporate Feud, filed a complaint against U S WEST Communications, Inc. in Docket No. UT-000096. The complaint alleges that the respondent has violated state laws by unlawfully disconnecting complainants telecommunications service and failing to provide prompt, efficient, or adequate service to the complainant. The complainant prays for imposition of sanctions or fines, damages, and refund of various billings from the respondent. Respondent filed its answer on February 15, 2000 in Docket No. UT-000096. On March 7, 2000, respondent filed an Answer and Affirmative Defenses of U S WEST Communications, Inc., in which it incorporates a response to both complaints in Docket Nos. UT-000014 and UT-000096.

A more detailed account of the disputes are reflected in the foregoing pleadings, which are available for inspection at the Commission's office, Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington. It is appropriate that the matters raised in the pleadings be brought to a hearing before the Commission.

In as much as the foregoing matters involve common questions of fact and law, they should be consolidated for hearing and determination, pursuant to WAC 480-09-610(2).

The issues involved are generally stated above and more specifically contained in the pleadings herein.
