Description of amendment: Implements the Commission's orders in UT-043013.

The amendment amends the interconnection agreement first accepted by the Commission on 08/09/2000 in WUTC Docket No. UT- 003052. That agreement was originally approved by the Commission on 08/25/1997 in WUTC Docket No. UT-960307 between Company A and Company C, AT&T Communications of the Pacific Northwest, Inc.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
