SOLID WASTE COLLECTION SERVICE in that portion of Asotin County described as follows: Starting at the southwest corner of Sec. 3, T9N, R43E (also the Asotin-Garfield County line); then northeasterly along the Asotin-Garfield County line to its intersection with the Asotin-Whitman County line (also the centerline of the Snake River): then easterly along said county line to its intersection with the Idaho-Washington State line (also the centerline of the Snake River); then southerly along said state line to its intersection with the south line of Sec. 20, T7N, R47E; then west along the south line of said section extended to the southwest corner of Sec. 24, T7N, R44E; then north along the west line of said section to the northwest corner of Sec. 25, T8N, R44E (also the northeastern boundary of the Umatilla National Forest); then northwesterly along the northern Umatilla National Forest boundary to the southwest corner of Sec. 3, T9N, R43E (also the Asotin-Garfield County line), the point of beginning.

SOLID WASTE COLLECTION SERVICE in that portion of Garfield County described as follows: Starting at the southwest corner of Sec. 31, T10N, R42E; then northerly along the Columbia-Garfield County line (also the west line of said section) to its intersection with the southwest corner of Sec. 36, T12N, R40E; then north along the west line of said section to its intersection with the south line of Sec. 35, T13N, R40E; then west along the south line of said section to its intersection with the Southwest corner of said section; then north along the west line of said section to its intersection with the Garfield-Whitman County line (also the centerline of the Snake River); then easterly along said county line to its intersection with the Asotin-Garfield County line (also the east line of Sec. 1, T11N, R44E); then southwesterly along the Asotin-Garfield County line to its intersection with the north line of the Umatilla National Forest (also the south line of Sec. 4, T9N, R43E); then west along the north line of the Umatilla National Forest to its intersection with the Columbia-Garfield County line (also the southwest corner of Sec. 31, T10N, R42E), the point of beginning.

SOLID WASTE COLLECTION SERVICE in that portion of Whitman County described as follows: Starting at the point where the Asotin-Whitman County Line (Snake River Centerline) intersects the Idaho-Washington State Line; then westerly along said county line to its intersection with the extended north line of Section 18, T11N, R45E; then east along the north line of said section to its intersection with the Idaho-Washington State Line; then south along said state line to its intersection with the Asotin-Whitman County Line (Snake River Centerline), the point of beginning.
