Request to Increase the Washington Telephone Assistance Program Rate from

\$4.00 to \$9.00 per month.

On June 25, 2003, the Department of Social and Health Services (DSHS) filed a request with the Commission to increase the customer payment rate for Washington Telephone Assistance Program (WTAP) service from \$4.00 to \$9.00 per month. The Commission will discuss the filing and take public comment at its regularly scheduled open meeting on **July 9, 2003, at 9:30 a.m.** You may comment on this filing at the open meeting. - The title and date of the comment or comments
