In accordance with WAC 480-07-640, Company A requests approval of a fully negotiated interconnection agreement including any amendment(s), as described below (the Agreement):

- January 7, 2004 letter from Lisa Korner Butler on behalf of World Communications, Inc. advising the Commission that it is adopting the Verizon Northwest Inc. – Tel West Communications, LLC interconnection agreement approved in Docket No. UT-990305, and requesting the Commission’s approval.
- July 1, 2004 adoption letter relating to the Verizon Northwest Inc. – Tel West Communications, LLC interconnection agreement , signed by Verizon Northwest Inc. and World Communications, Inc., and Appendix A setting forth certain rates.
- Interconnection, Resale and Unbundling Agreement between GTE Northwest Incorporated and AT&T of the Pacific Northwest, Inc. originally approved by the Commission on 8/25/1997 under Docket UT-960307, and adopted by Tel West Communications LLC on 2/10/1999 under Docket UT-990305.
- September 25, 1997 cover letter and revised Attachment 14 AT&T/GTE Pricing Agreement submitted on that date as a correction under Docket UT-960307.

Company A represents that the Agreement does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B’s signature on the Agreement, Company A believes that Company B agrees with these representations.
