

COMES NOW Pend Oreille Telephone Company, by and through its attorney of record, Richard A. Finnigan, attorney-at-law, and pursuant to WAC 480-370(c) files this Answer to Formal Complaint. Admissions:

1. Pend Oreille Telephone Company admits that: (1) it is a telecommunications company operating in the State of Washington with its address at 892 W. Madison Avenue, Glenns Ferry, ID 83623; (2) its general telephone number is (208) 366-2840; (3) its registered agent is CT Corporation located at 520 Pike Street, Seattle WA 98101; (4) its UBI Number is 601-503-481; and (5) its President is Mr. James Martell.

ANSWER TO FORMAL COMPLAINT- 1

Pend Oreille Telephone Company also admits that Public Utility District No. 1 of Pend Oreille County, Washington (PUD No. 1) has an address of PO Box 190, Newport WA 99156 and a telephone number of (509) 447-3137.

Denials:

3. Pend Oreille Telephone Company is either without knowledge sufficient to know the truth or falsity of the allegations contained in the Formal Complaint and therefore denies the same or expressly denies the same. Further, Pend Oreille Telephone Company denies that any relief is entitled to PUD No.

Affirmative Defenses:

- 4. By way of affirmative defenses, Pend Oreille Telephone Company alleges as follows:
 - 1. The Formal Complaint filed by PUD No. 1 is based upon unsubstantiated hearsay and fails to state a claim upon which relief may be granted;
 - Pend Oreille Telephone Company has never received a request for service from PUD No. 1
 as described in the Formal Complaint and therefore the Formal Complaint should be
 dismissed as premature or not yet ripe;
 - 3. PUD No. 1 is not a telecommunications company as defined by Washington statute and is not entitled to receive wholesale services from Pend Oreille Telephone Company and this matter should be dismissed for failure to state a claim or as beyond the subject matter jurisdiction of the Commission;

- 4. PUD No. 1 has never filed an interconnection request with Pend Oreille Telephone

 Company, has not requested negotiations of any sort with Pend Oreille Telephone Company
 and the Formal Complaint should be dismissed as improper and beyond the jurisdiction of
 the Commission as exceeding the Commission's delegated authority under Sections 251 and
 252 of the Telecommunications Act of 1996;
- Pend Oreille Telephone Company and RCC Holdings, Inc. have reached an agreement in principle under which Pend Oreille Telephone Company will provide services to RCC Holdings, which agreement is in the process of being reduced to writing and, therefore, this Formal Complaint should be dismissed as moot;
- 6. PUD No. 1 lacks standing to assert a claim on behalf of an unrelated third party;
- 7. PUD No. 1 has engaged in conduct which exceeds its statutory authority and the Formal Complaint should be dismissed under either the doctrine of estoppel or the doctrine of unclean hands.

Relief Requested:

5. Pend Oreille Telephone Company respectfully requests that the Commission dismiss the Formal Complaint on its face.
