Amendment No. 1 incorporates the Triennial Review Order and the Triennial Review Remand Order into the Interconnection Agreement between Qwest Corporation and Orbitcom, Inc.

Amendment No. 2 provides terms and conditions for the purchase of the Qwest Platform Plus Service.

That agreement was originally approved by the Commission on September 17, 2004 (date) in WUTC Docket No. UT-043057 (original docket number) between Qwest and Covista, Inc. (name of company C).

The Commissioners, having reviewed the information available in this matter and having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
