BACKGROUND

- Verizon Northwest Inc. (Verizon NW or Company) requested on August 5, 2008, that the Washington Utilities and Transportation Commission (Commission) overturn the North American Numbering Plan Administrator's (NANPA's or Numbering Administrator's) decision to withhold numbering resources and direct the Number Pooling Administrator (NeuStar, Inc.) to open a code in the Everett rate center. Verizon NW requires a waiver to permit the assignment of a number code for utilization of a new central office switch in Everett, Washington. This new switch will enable the Company to provide Internet Protocol (IP) enabled services, broadening the range of choices available in the market, and enhancing customer options. The Company asserts that these service choices will be in the public interest.
- 2 The new Verizon NW switch requires its own number code in order to establish a Local Routing Number (LRN) for network billing identification. The Pooling Administrator will designate Verizon NW as the code holder and will subsequently assign one, one-thousand number block of the new code to Verizon NW. The other nine blocks will be returned to the administrator to replenish the number pool inventory in the Everett Rate Center. The 425 NPA is forecasted to exhaust in the first quarter of 2031 and there are 293 unassigned codes in the 425 NPA. Verizon NW provided the Commission with a detailed inventory for number resources and "proof of utilization" in the rate center. Verizon NW will adhere to the requirement to review numbering resources and comply with the requirements of the FCC's NANPA and the Pooling Administrator regarding the return of unused numbers.
- Telephone companies or carriers commonly hold and manage a reasonable inventory of telephone numbers in the areas where they provide service. When more are needed carriers request them from the Numbering Administrator. The Numbering Administrator

withholds telephone numbers if a company's inventory is sufficient for the next four months and there is a shortage of numbers in the affected area code.

The Federal Communications Commission (FCC) issued an order establishing a "safety valve" allowing carriers that do not meet the utilization threshold in a given rate center to obtain additional numbering resources apart from the general waiver process.¹

Specifically, the FCC granted to state commissions the authority to direct the Number Pooling Administrator to release numbers to a carrier to satisfy a specific request that cannot be met with the carrier's current inventory.²

FINDINGS AND CONCLUSIONS

- The Washington Utilities and Transportation Commission is an agency of the State of Washington vested by statute with the authority to regulate the rates, rules, regulations, practices, accounts, securities, transfers of property and affiliated interests of public service companies, including telecommunications companies. *RCW* 80.01.040, *RCW* 80.04, *RCW* 80.08, *RCW* 80.12, *RCW* 80.16 and *RCW* 80.36.
- 6 (2) Verizon Northwest Inc. is a telecommunications company and a public service company subject to Commission jurisdiction.
- 7 (3) The Telecommunications Act of 1996 (the Act) allows the FCC to establish rules to implement the Act and delegate authority to state commissions.
- The FCC has created a "safety valve" mechanism within the framework of number resource management and delegated to the Commission authority to grant requests by carriers that require numbering resources that exceeds their available inventory. The FCC has also given states some flexibility to direct the Number Pooling Administrator to assign additional numbering resources to carriers that have demonstrated a verifiable need for additional numbering resources.³

- 9 (5) The Commission has jurisdiction over this matter pursuant to RCW 80.36.610, which authorizes the Commission to take actions necessary to implement the federal Telecommunications Act of 1996.
- Normally, additional numbering resources are granted only when existing resources are forecasted to exhaust within six months.⁴
- 11 (7) The Number Pooling Administrator's Web site reports an inventory of 293 codes in the 425 NPA, Everett rate center, and indicates that the exhaust is scheduled for the first quarter of 2031.
- 12 (8) This matter came before the Commission at its regularly scheduled meeting on. September 11, 2008.
- 13 (9) The allocation of the requested number resources is necessary for community interests, competitive growth and network development in the Everett area. It is therefore consistent with the public interest.

ORDER

THE COMMISSION ORDERS:

- 14 (1) NeuStar, Inc., acting as the Number Pooling Administrator, to release one code in the 425 NPA for Everett rate center to Verizon Northwest Inc.
- 15 (2) The Commission retains jurisdiction over this matter to take such future actions as may be appropriate.

The Commissioners have delegated authority to the Secretary to enter this Order pursuant to RCW 80.01.030 and WAC 480-07-904(1)(g).
