Re: Centralia Rate Center Numbering Waiver

Dear Ms. Washburn:

By this letter Qwest is requesting a waiver of the utilization threshold requirements outlined in FCC's Numbering Resource Optimization Orders, FCC 00-429 and FCC 01-362 released in CC Docket No 99-200, which would allow PA/NeuStar, the Number Pooling Administrator, to open a new NXX to meet the needs of a specific Qwest customer.

The customer request is for 2,500 sequential telephone numbers in the 360 NPA, Centralia Rate Center. Specifically, the customer has requested that the numbers be in a single prefix. The customer intends to have the new numbers in use starting the first quarter 2009. Qwest asks that the WUTC authorize NeuStar assign an NXX that would meet the customer's needs from the 360 NPA Centralia Rate Center. The 360 NPA is forecasted to exhaust in the second quarter of 2011. There are 64 unassigned NXXs in the 360, and no 1K thousands blocks in the PA pool inventory for the Centralia Rate Center. When Qwest receives the new NXX, Qwest will retain 3 blocks and the other 7 blocks will be held by the Pooling Administrator for the industry inventory pool.

The customer intends on returning 600 numbers of their current inventory of telephone numbers after the new numbers are in service. The original customer request has been provided with this letter as Confidential Attachment A.

In our effort to satisfy the customer's request, Qwest submitted a request to PA/NeuStar on October 1, 2008 for additional numbering resources. That application and the subsequent denial have been provided as Confidential Attachment B. In order for the request to be approved, Qwest will require a waiver of the current usage threshold for new numbering requests.

The FCC allows for a waiver of the rules when there is demonstrated need such as a specific customer request for a large block of numbers. The waiver process is specifically addressed in the FCC Third Report and Order ("Order") as the "safety valve" process (See FCC 01-362, paras. 57-66), which went into effect on March 14, 2002. The Order delegates the authority to hear claims for waivers to the state commissioners and recommends that state commissions act expeditiously. The Order proposes that state commissions review a waiver within 10 business days. (See Paras. 61,66)

Qwest respectfully requests that the Commission approve the request for a waiver of months to exhaust and rate center utilization threshold requirements, and direct PA/NeuStar to assign one NXX in the 360 NPA in the Centralia Rate Center to accommodate our customer's request.
