

PREPROPOSAL STATEMENT OF INQUIRY

Agency: Washington Utilities and Transportation Commission	
Subject of possible rule making: The subject of the inquiry is to consider whether the Utilities and Transportation Commission (UTC) should propose revised regulations to implement additional consumer protection disclosures in WAC 480-120-264(5), "Disclosure requirements - Prepaid calling services." Specifically, whether the UTC should add new subsections to (5)(a), as follows: (vii) The disclosure of rates, terms, and conditions must be made in the language in which the card is advertised. (viii) The number of minutes contained on the card must be disclosed on the card or its packaging. The UTC has commenced this rulemaking under Docket UT-100148.	
Statutes authorizing the agency to adopt rules on this subject: RCW 80.01.040 and RCW 80.04.160.	
Reasons why rules on this subject may be needed and what they might accomplish: The UTC is responsible for protecting consumers by ensuring that investor-owned utility services, such as pre-paid calling card services, are fairly priced, available, and reliable and by enhancing information to better enable competitive choices for consumers of utility services. The additional disclosures have been proposed at the federal level for interstate services and the UTC believes that the same information would be beneficial for intrastate services. The existing rule on prepaid calling services already includes several protections and disclosures. The enhancements mentioned above, as the subject of possible rule making, are consistent with the UTC's mission.	
 Identify other federal and state agencies that regulate this subject and the process coordinating the rule with these agencies: Federal and state laws and rules apply. The agencies other than the UTC that have authority concerning prepaid calling services include: The Federal Communications Commission (FCC), the Federal Trade Commission (FTC), and the state Attorney General's Office (AGO). The laws and regulations that apply overlap and complement each other. That is not expected to change under any likely scenario.
