On January 29, 2010, Puget Sound Energy (PSE) filed with the Washington Utilities and Transportation Commission (Commission) a report concerning its ten-year conservation potential and its biennial conservation target.

The report is required by RCW 19.285.040 and WAC 480-109. WAC 480-109-010 (4) provides that Commission staff and all interested parties may comment on a utility's report concerning its ten-year conservation potential and its biennial conservation target.

Oral comments may be presented in-person at the open meeting of the Commission to be held on **Thursday, March 11, 2010**, which is scheduled to start at 9:30 a.m. The meeting will be held at the Commission's headquarters, Room 206, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.

The Commission will consider all comments and determine whether additional scrutiny is warranted, and may establish an adjudicative proceeding or other process to fully consider appropriate revisions. Upon conclusion of its review, the Commission will approve, approve with conditions, or reject PSE's ten-year conservation potential and biennial conservation target.
