October 7, 2010

After nearly 40 years of operations the Crosswoods Water System has installed a hypochlorination system in order to comply with Department of Health regulations. The final cost for the installation is \$25,686 and the estimated increase in operations due to treatment system management and testing is \$8,073 annually.

The company is in the process of filing a request for the approval of a surcharge by the Utilities and Transportation Commission (commission) to cover the installation of the treatment system as well as a tariff rate increase to cover the increased cost of operations. The surcharge would be a temporary 5 year rate of \$3.84 per user per month or an up-front payment amount of \$202.25. The increase in the base rate cost will be \$3.85 per user per month. The surcharge is set to expire on November 30, 2015 or upon recovery of \$25,686 loan principal plus interest charges and state excise taxes, whichever occurs first. If approved, the rate increase and surcharge will be effective on December 1, 2010 and reflect on your monthly usage bill.

Following is a comparison of the current and proposed rates:

Commission staff will make a recommendation to the commissioners at an open meeting in Olympia, which is scheduled for 9:30 a.m. on November 24, 2010. You will have an opportunity to comment in person at this meeting.
