Amendment No. 1

Interconnection, Collocation and Resale Agreement

and

Axxis Communication Inc.

Amendment No. 1, made this 8th day of August, 2013, is entered into by and between Axxis Communication Inc. ("CLEC"), and United Telephone Company of the Northwest d/b/a CenturyLink ("CenturyLink") for the state of Washington. CenturyLink and CLEC are referred to herein as the "Parties".

BACKGROUND:

WHEREAS, the Parties entered into an Interconnection, Collocation and Resale Agreement for the state of Washington ("Agreement") the 7th day of May, 2010.

WHEREAS, the Parties wish to amend the Agreement to modify the existing rate sheet for cross-connect facilities.

In consideration of the promises and agreements contained in this Amendment, the Parties hereby agree as follows:
