Malik,

The Washington Utilities and Transportation Commission (UTC) received Yakima County's (County) Grade Crossing Protective Fund (GCPF) application for installation of activated advance warning signage along South Track Road near highway railroad grade crossing#104518X.

I will be sending you a letter notifying the county that UTC does not have any GCPF funds remaining in the current biennium which ends June 30, 2013. UTC anticipates that GCPF funding will be available at the beginning of the next biennium, July 1.

Staff will hold off evaluating the County's application until this time. However, in the meantime please supplement the application with a breakdown of the estimated total cost of the project, as requested in Section 10 of the application. The application states a quote is attached but one was not submitted. Also, UTC typically awards up to \$20,000 per project. Can you clarify if the County would be able to contribute the remaining amount of \$20,000 to complete the project.


