The two purposes of this filing are to: 1) revise the filing to adjust the residential rates downward in accordance with Commission Staff's suggestion to revise and limit the incentives for electric vehicle chargers; and 2) remove all of the costs – which only included incremental labor costs – associated with the Conservation Program named Conservation Voltage Regulation which results in a small reduction in rates for all customers. Revised work papers are attached. The filing also updates Sheet No. 120 to reflect Schedules 195 and 7A.
