Tariff No. 16, 2nd revision, Page 34 Item 230 disposal fees for drop box disposal service at Royal Heights Transfer Site, Raymond, WA is \$103.25 per ton.

Proposed changes are:

Peninsula Sanitation Service, Inc. proposes revising Tariff No. 16, 3rd Revision, Page 34, Item 230 for drop box disposal service to become effective on less-than-statutory notice on November 1, 2014. The per ton rate in the Memorandum of Understanding between Pacific County, the cities of South Bend, WA and Raymond, WA. and Royal Heights Transfer Station, Inc. has increased from \$103.25 per ton to \$104.24 per ton. Peninsula Sanitation Service, Inc. serves approximately 4,800 customers in Pacific County of which two compactor drop box customers are affected by this increase. A copy of the memorandum of understanding is attached to this LSN.
