Company proposes to change Tariff item # 5 (Application of Rates – Taxes) (page 5) Number 11  
(Tariff, time schedule, etc.)

**Present provisions are:**

\$1.08 per month for residential customers in King County and \$11.24 per month for non-residential (Commercial and Industrial) customers in King County

**Proposed changes are:**

\$0.84 per month (*REDUCTION*) for residential customers in King County and a tiered (usage-based) system for non-residential (Commercial and Industrial) customers in King County, of which, approximately 20% will pay less than they are now, 71% will pay about a dollar more, and about 8% will pay about \$35 more.

**Indicate below, or attach, an explanation of the reason the company requests permission to file and publish the proposed provisions with less than statutory notice.**

Although many of the customers will experience a reduction in fees, high volume non-residential accounts will see an increase. The company has been working with the commission staff and King County on this filing since late 2014 but submitting the prepared tariff pages was unintentionally delayed past the 45 day requirement for increased charges to customers.
