Waste Management is pleased to be your solid waste services collection provider. We value your business and welcome your feedback on our services.

Like all of us, the garbage industry is faced with many challenges today. Rising costs for disposal, processing yard waste and recyclables, labor, maintenance and office expenses have resulted in increased costs for us to provide collection services. Many of the above-mentioned costs have risen since our last general rate increase in January, 2014. Accordingly, we have applied for a change in rates, subject to the review and approval of the Washington Utilities and Transportation Commission (UTC). The UTC, upon completing its investigation, has the authority to set final rates that may be either lower or higher from the proposed rates shown on the back of this letter. If approved, the new rates would become effective September 1, 2015.
