We have since then learned the right way to check and maintain the proper driving abstracts as per according to Title 49 (CFR). We will run yearly abstracts and have our employees inform us of any violations that they might have gotten in the previous year.

Violation # 3 Record of duty status.

We have set up a new form of tracking hours for full times and part time employees.

This will make sure that they do not go over the HOS rule. These new time sheets and records will track time in a proper manner.
