RATE INCREASE NOTICE FOR RESIDENTIAL GARBAGE SERVICES

Dear Customer:

February 28, 2018

Columbia River Disposal, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC April 1, 2004. Since that time, the Company has experienced increases in operating costs in the areas of labor, employee benefits, fuel, parts and equipment amongst other categories which it now seeks to update in rates.

If approved, the proposed rates will become effective April 1, 2018. The rate per month will increase as follows:

The Commission has the authority to set final rates that may be either lower or higher from the Company's request, depending on the results of its investigation. Commission staff will make a recommendation to the Commissioners at an open meeting in Olympia, which is scheduled for 9:30 a.m. on March 29, 2018.
