

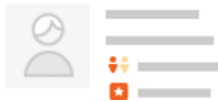

DO NOT USE THIS COMPANY. I cannot reiterate that enough. This company also goes by the names: The Wright Move & Man with a Van. Do not use any of these companies as they are all the same, terrible company.

I wish I could give this business 0 stars. My family recently used this company and had a very traumatizing move due to their incompetence, complete lack of respect for our possessions and our time. I don't even want to rehash all of the failures but here is the gist: movers were late, truck was not big enough, they ran out of gas on the freeway in the van which caused greater delays, they didn't wrap many furniture items, they damaged thousands of dollars worth of furniture, they were impossible to get ahold of, they charged full price, they eventually fixed some of the furniture but not all of it. It took 1.5 months to get our furniture back, they hadn't even fixed everything and there was no indication that they actually planned on returning these items without constant badgering. The people who "run" this company, do so extremely poorly and are dishonest. They will try to take advantage of you. They will ruin your belongings, take little accountability, waste your time and still take your money.

So angry today, I don't even know where to start! DO NOT USE THIS COMPANY! I hired Tacoma Movers to move a one bedroom apartment for our daughter about a week before her move. We settled on a price of \$300 for 2 guys for four hours and he would waive the \$100 travel fee, and we were to pick up our own moving truck. As soon as I booked him, I read several of these bad reviews, and called him right back to cancel. He wasn't answering the phone, and after several attempts, I got an answering machine with a British voice for another company with the name of "The Wright Move"! By now I was really uncomfortable about the sketchiness! Finally got him to answer and He informed me that if I cancelled he would charge me a \$100 cancellation fee. Since he already had my credit card information, I decided to go ahead with him if he would guarantee that two guys would be there at 9 a.m. on the following Saturday. I told him I would like to be able to write a good review for them. The day before the move, I finally got an email from him saying they would be there between 10 and 11 a.m. and the fee would be \$400. I called him and had to remind him that we had agreed on 9 am and \$300 flat fee. He said ok to that and that his guys would be there between 9 and 10 a.m. The next day, we got our truck at 8:30 a.m. and my husband (who is 70), my son, my daughter and myself starting packing the truck. Two young guys finally arrived at 11 a.m. and said they had been at another job before ours! They did not seem very professional or adept at moving - we went upstairs to the apartment and the first guy started carrying only 2 small shelves from a bookcase under his arm and fell down the stairs, spraining his ankle! His brother carried down one item and then they went back to their truck to check it out and said he would try to "walk it out" for awhile while his brother stood by eating a yogurt! I texted Anthony to let him know what happened and that I wasn't comfortable having someone who is hurt continue to try to work. The one who wasn't hurt started working with us, and helped my son get a sofa that was difficult to move through the doorway and down the stairs. He then said, "boy I need a little break after that!". My son worked twice as hard as he did! Anthony finally showed up about 12:15 and said he would work himself until the next replacement guy could show up. We settled on the price again, since we had only had one guy for the first hour, and confirmed that they would stay until 3:30. I asked if there was a contract for me to sign, and since he said no, I wrote it out on a piece of paper and had him sign it, so there would be no discrepancy about the price. How unprofessional is that? He then went with my

husband and son to the other apartment 2 miles away to unload the truck. They were unable to fit my daughter's sofa and loveseat through either entry to the upstairs apartment, due to the doors being narrow. My husband called me and said we would have to take them to Goodwill since there was nothing else to do. The sofas were badly in need of cleaning, but were sturdy Lazy Boy brand, so it was too bad we couldn't try to sell them but had nowhere to store them. Anthony said he would be happy to take them and make sure they were donated to someone. Today, in trying to look up other reviews on him, I found that through Facebook he has many items listed for sale on "offer up" - guess what is listed for \$250?!!! Funny thing is, we realized we still have all the "feet" to both sofas that we unscrewed trying to get them through the doors, so good luck trying to sell them! How unscrupulous! The final blow, was that he came back to our first location to "settle up" with me after a 3rd guy arrived to help, but about 45 minutes before the guys were supposed to be done. He wanted cash instead of a credit card and said he thought he had told me that before - he said he only took my credit card info before to reserve the move. When I said I didn't have that kind of cash, he said he would follow me to an ATM since he had to get going. He said he liked to get cash so he could pay his guys right away. I said, "how can you pay them right away if you are leaving" and he laughed and said he would catch them at their next job. Can't believe I agreed, but I just wanted to be done with him. He followed me and parked in an alley while I got the money - felt like a drug deal or something as sleazy. The guys ended up leaving at exactly 3:30 even though we weren't done, and seemed upset that we weren't paying them - I wonder if they even got paid! Today I cancelled my credit card since he has all my information and I don't trust him. I DO NOT RECOMMEND HIM AT ALL! He has 3 company names, so avoid them all: A Man and a Van; Tacoma Movers; and the Wright Move

They came with 2 movers and no tools. Took almost 4 hours to move a 700sq 1 bedroom. They damaged our bed and rental apartment wall.

Unloaded very quickly because we didnt know what was coming. They wanted to quote us 800 for a 1 bed room move. Stating 4 hour minimum, travel fees, and what not. They dropped it to 615 and kept throwing in our face how they did us a favor and travelled to accomodate the charging because they have to get your signature in person.

They may talk a talk but honestly stay away. This is very expensive moving and we were caught blindsided just seeking for help and beeing in a bind. Also wanted to discuss second move after ripping us....just go somewhere else.

2. Only 2 people for the entire job. I had to help to get things done on time (or you get charged more for time).
3. Had a small moving truck for a 1 bedroom apt (everything barley fit in 1 load).

The people doing the moving were great. But it was only 2 vs 3. I was quoted 3 and had no room to argue since we had to move that day. They explained that the other guy was helping another move. (didn't explain why they shorted me). I saw one of the guys drop our box and heard a crunch. Didn't realize it was our neatly packaged bowls that my wife collects. I was referred to Anthony/Tacoma Movers through the Veteran's Movers USA company. Anthony was very professional and responsive, giving a confirmation call the day before and listened carefully to my concerns. The two movers he sent out were very strong and the lead, Michael was experienced, as requested. They arrived at 8:15 am, actually earlier than the 8:30am scheduled time. Everything that wasn't already boxed, they shrink wrapped and taped before moving. I had rented a U-Haul truck which they packed very nicely. It was a difficult move- lots of stairs- and they did a great job. No damage to anything, that I've noticed. The move took longer than I expected, but as I said it was a difficult job, so they were probably 2 hours late to their afternoon job. The only reason for the four stars, instead of five is that I wasn't notified ahead of time -until the movers were at my apt- that the staircases were an extra fee per hour.

If there were 0 stars this is what they would get. I dealt w/ Anthony Wright the owner in 2014 to move my 499 sq ft studio into storage. It took at least 4.5 hours to do the "moving" and all they had to wrap was the kitchen and stuff under the bathroom counter I had put everything in plastic tupperware containers for them. He charged several hundred dollars. Also he laughs and jokes around the whole time he is "working". He moves slow as a snail. He showed up w/ 3 guys to pack me plus himself so I didn't mind he kept leaving to take personal calls...Let's get to my move out of storage where the appalling story begins...I returned from deployment and thought I would use him as a previous client to get a discount. He quoted \$150 for 1.5 hours plus \$15 for gas for the 2.8 mile drive from my storage unit to my condo. I made an appointment for 4:30 pm on a Wed, at 4:35 pm 5 min after my appt i called him and he said their truck broke down and could he reschedule to the next day--- no courtesy call all day or ANYTHING, this was the first time he disrespected me and at this point I had 3 days to get my stuff out of storage. So the next day Thursday he called at noon to confirm 6 pm and I said that was late at night but ok, here's the problem he was too busy and could have just told me he was booked that day but instead he wanted to get that \$165 from me so he lied and said he would be at Tacoma Self Storage at 6. I called at 6 and he said he was in traffic 20 min away from Tacoma Mall where he needed to pick up his worker to help him and grab a truck?! I told him I was 20 min past the mall-- that puts us at 6:40 pm. He showed up after 7 and wasn't parked and working til 7:30 pm he was also still giggling in my face VERY Disrespectful for someone who is an hour and half late. He brought 1 guy and just himself (mind you he kept taking phone calls from friends talking about where he wanted to eat dinner while slowly pushing dollies w/ 1 hand as his phone was on his shoulder) his younger worker named Jesus was busting his tail ALONE. My friend Asked if we could speed things up since it was late at night and he said "yeah you guys (meaning myself and my friend) could pack all of my stuff onto carts for them" out of my storage unit then take them downstairs so they could spend time loading the truck on the bottom floor-- why would I unload my own storage unit? I thought that's why you hire movers?!?! It started pouring rain and i went outside and found a cart of my stuff sitting out in the rain not being loaded, even though there was a large overhang they could have left the cart under. We only has to drive down a few streets to my place and Anthony is still taking calls from his girlfriend about dinner plans and Jesus is moving my stuff alone in the rain. They scraped my bookshelf on the walls all the way up my stairs and I found huge chunks of wood and screws that had fallen out on my staircase leading to my condo. It took them until 9:45 pm and I wanted him out of my condo and life. He said "we went over the hour so you owe me another \$50," which he never told me about during the estimate or that night when I re-confirmed the total price. \$215 for a guy to

leave my boxes out in the rain, damage a bookshelf and waste 2 nights of my life...DO NOT use "Tacoma Movers" or his other Company name "Man And A Van," save yourself the stress and money from this horrible business owner who thinks everything is a joke and doesn't know how to schedule moving times or account for traffic between clients. Bottom Line: He does NOT care! I will make it a point to ensure noone uses this man for their moves. I wanted to help a small business, but this guy is a joke and a con artist who comes up with last minute fees and purposely goes slow to charge you more \$\$\$!!!

Anthony seemed professional enough over the phone... I should've known something was up when I called a week later and no answer and no return call... But I had my husband call and reserve these guys for the move.

Sooo again the day started great, until Anthony and his van were 5 hours late... Yes 5!!!! My husband was waiting for him at the old apartment and I was at the new house. So instead of 3 pm Anthony his van and a buddy showed up at 8pm!!! And being 5 hours late isn't even the worst part. :(

Ok ok so fine they started loading and then headed to the new house. They brought in one small couch.... Then the large couch... And then one large dresser. I noticed a strange smell... But didn't think too much of it. They left and headed back to the apartment for the last load... (I was shocked they couldn't fit it all in their what appeared to be quite large truck... Which turned out to be a large renovated moving truck with windows and curtains... So moving truck/ motor home? Weird.

Anyways... I was inside the new house and that strange smell I didn't think too much of, turned into a overpowering stench of fuel... I thought I was losing my mind so I went around and sniffed everything... Only thing I could think of was a gas leak in the basement... But the basement didn't smell at all. :-/ so I sniffed the couches... I noticed wet spots on the couches but I thought it has just been since it was rainy and they were carried outside for a little bit. Turns out the small couch smelled just fine.... But the large couch. The large couch was soaked in fuel.... And the smell was only getting worse since the movers and my husband left we had now closed the doors. I called my husband and told him about the smell... And fuel all over our couch. He asked Anthony why and how that could be. Anthony told him there was a gas can in the back with our stuff and it must be just fumes because the gas can was empty... Let me tell you, that gas can was empty now because it had spilled all over the couch. :(

So they all get back to the house, at this point the smell is so strong I feel it isn't safe to be breathing in for any human especially since I'm 9 months pregnant and about to pop. I was so upset and sad, I just wanted to be moved in and getting ready for our baby to come. So Anthony comes in the house with my husband and they smell the fuel and sniff the couch... Anthony agrees it stinks but he insists that the fuel will be able to get washed out. I'm not kidding when I say the smell was far stronger than when you are at a gas station and accidentally spill some gas on the ground. I figure at this point I need Anthony's information, his business license and insurance information... Not only is our couch ruined but the entire house smells of fuel and we can't stay I the house until the smell is gone, it's not safe to be breathing in.

Anthony would not provide me any of his information and

was insisting that he would give it to is the next day during normal business hours. I said no before he leaves he needs to give me something and he refused... At this point I don't trust him and don't know how I will be able to get this info at a later time... So I only have one option and that is to call the cops and have them get his info for us. The cops took a little while to get there and it was already after 10pm at this time, and we all wanted this to end. But I told them to stay or let me see their business info and license... 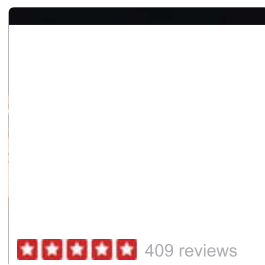

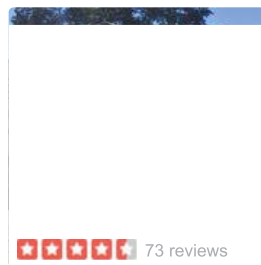

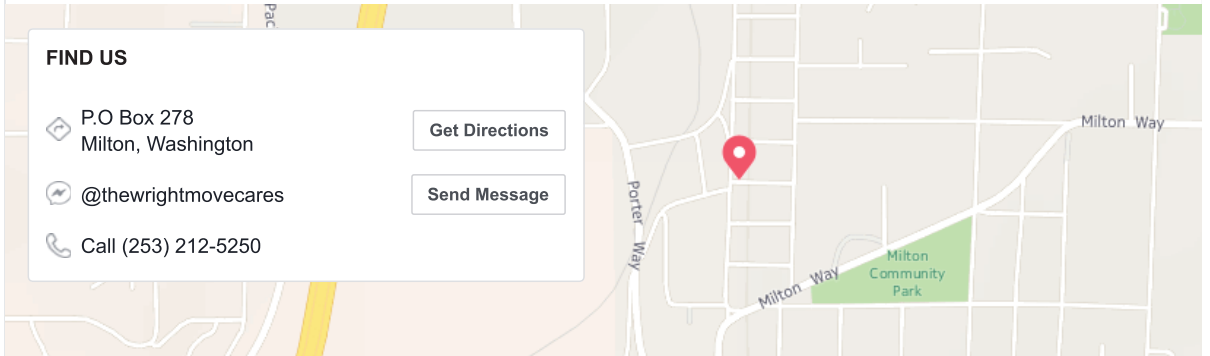

INTRODUCTION

Synopsis. *This is an Administrative Law Judge's Initial Order that is not effective unless approved or allowed to become effective as described in the notice at the end of this Order. This Initial Order is based upon a stipulation presented by the parties. If this Initial Order becomes final, Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers will be assessed a financial penalty in the amount of \$5,000 for two (2) violations of RCW 81.80.075(1). A \$4,500 portion of the penalty will be suspended for a period of two years from the date of this order, then waived, subject to the condition that Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers refrains from further operations as a household goods carrier without first obtaining the required permit from the Commission. The remainder of the penalty, \$500, is due and payable subject to the payment schedule in Appendix A. In addition, if this Initial Order becomes final, Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers, will be classified as a household goods carrier and required to permanently cease and desist from operating as a household goods carrier without first obtaining a permit from the Commission.*

1 **Nature of Proceeding.** The Washington Utilities and Transportation Commission (Commission) initiated this special proceeding to determine if Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers, has engaged, and continues to engage, in business as a common carrier for transportation of household goods for compensation within the state of Washington without possessing the permit required for such operations.

2 **Procedural History.** On September 29, 2014, the Commission entered Order 01, Order Instituting Special Proceeding; Complaint Seeking to Impose Penalties; and Notice of Mandatory Appearance at Hearing, pursuant to RCW 81.04.510, initiating this docket on its own motion. The Complaint alleges that Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers violated RCW 81.80.075(1) by:

(1) offering on at least one occasion to transport household goods within the state of Washington

(2) advertising household goods moving services within the state of Washington on at least one occasion

without the necessary permit required for such operations. On the same date, the Commission issued a *Subpoena and Subpoena Duces Tecum For Production of Documents* (Subpoenas) to the company commanding Anthony Wright to appear before the Commission at a special proceeding scheduled to convene at 9:30 a.m., November 4, 2014, in the Commission's offices at 1300 S. Evergreen Park Drive S.W., Olympia, Washington, and to bring the documents specified in the *Subpoenas*.

3 **Hearing.** On November 4, 2014, the hearing convened, as scheduled, in Olympia, Washington, before Administrative Law Judge Rayne Pearson.

4 **Appearances.** Megan Banks, Compliance Investigator, Olympia, Washington, represents the Commission's regulatory staff (Commission Staff).¹ Anthony Wright, Tacoma, WA, represents Man and a Van, Inc. aka Tacoma Movers, *pro se*.

DISCUSSION

5 **Applicable Law.** RCW 81.80.010(5) defines "household goods carrier" as

¹ In formal proceedings, such as this, the Commission's regulatory staff participates like any other party, while the Commissioners make the decision. To assure fairness, the Commissioners, the presiding administrative law judge, and the Commissioners' policy and accounting advisors do not discuss the merits of the proceeding with the regulatory staff, or any other party, without giving notice and opportunity for all parties to participate. See RCW 34.05.455.

a person who transports for compensation, by motor vehicle within this state, or who advertises, solicits, offers, or enters into an agreement to transport household goods.

RCW 81.80.075 prohibits household goods carriers from operating for compensation in Washington without first obtaining the required permit from the Commission. Upon proof of unauthorized operations, RCW 81.04.510 authorizes the Commission to order the unpermitted company to cease and desist its activities. Additionally, RCW 81.04.110 authorizes the Commission to file a complaint on its own motion setting forth any act or omission by a company that violates any law, or any order or rule of the Commission.

6 RCW 81.80.075(4) subjects persons who engage in business as a household goods carrier in the state of Washington without the required permit to a penalty of up to \$5,000 for each violation. In deciding the penalty amount to be imposed per violation, RCW 81.80.075(4)(b) requires the Commission to consider two factors: (a) willingness to comply with the provisions of RCW 81.80.070 and the rules governing household goods carriers contained in WAC 480-15 and (b) compliance history.

7 **Stipulation Presented by Parties.** At hearing, Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers agreed that he has been operating as a household goods carrier in the state of Washington without the required permit. The company offered to transport household goods on at least one occasion and also advertised to transport household goods on at least one occasion.

8 Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers has agreed to permanently shut down and cease operations as a household goods carrier, as defined by WAC 480-15, without first obtaining a permit from the Commission.

9 Under RCW 81.04.075(4), Commission Staff is authorized to seek a penalty of up to \$10,000 against the company. Based upon the above-noted stipulation, Staff now seeks a lesser penalty of \$5,000 and, on condition of the company's honoring its pledge of future compliance by permanently staying out of the industry without first obtaining a permit from the Commission, seeks to have \$4,500 of the penalty suspended for two years, then waived.

10 The parties agree that the company's currently expressed willingness to cease its unpermitted operations is a positive factor, mitigating in favor of a lowered penalty

amount to be paid now. The parties also agree that the company's compliance history is a negative factor, making a suspended penalty appropriate as a tool to ensure Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers does not re-enter the household goods moving business without first obtaining the required permit.

FINDINGS AND CONCLUSIONS

- 11 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington vested by statute with authority to regulate persons engaged in the business of transporting household goods for compensation over public roads in Washington. The Commission has jurisdiction over the subject matter of this proceeding and over Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers, pursuant to RCW 81.04.510, RCW 81.80.010, and RCW 81.80.075.
- 12 (2) On at least one occasion, Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers offered to perform household goods moving services without first having obtained a permit from the Washington Utilities & Transportation Commission, in violation of RCW 81.80.075.
- 13 (3) On at least one occasion, Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers advertised to perform household goods moving services without first having obtained a permit from the Washington Utilities & Transportation Commission, in violation of RCW 81.80.075.

ORDER

THE COMMISSION ORDERS:

- 14 (1) Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers is classified as a common carrier of household goods within the state of Washington.
- 15 (2) Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers is ordered to immediately cease and desist operations as a household goods carrier within the state of Washington without first obtaining a permit from the Commission.
- 16 (3) Anthony Wright d/b/a Man and a Van, Inc. aka Tacoma Movers is assessed a penalty of \$5,000. A \$4,500 portion of the penalty is suspended for a period of

two years from the date of this Initial Order, and waived thereafter, provided Anthony Wright refrains permanently from further operations as a household goods carrier in the state of Washington without first obtaining the required permit from the Commission. The remainder of the penalty, \$500, is due and payable subject to the payment schedule in Appendix A.


- 17 (4) The Commission retains jurisdiction over the subject matter and the parties to this proceeding to effectuate the terms of this Order.



NOTICE TO THE PARTIES

This is an initial order. The action proposed in this initial order is not yet effective. If you disagree with this initial order and want the Commission to consider your comments, you must take specific action within the time limits outlined below. If you agree with this initial order, and you would like the Order to become final before the time limits expire, you may send a letter to the Commission, waiving your right to petition for administrative review.

WAC 480-07-825(2) provides that any party to this proceeding has twenty (20) days after the entry of this initial order to file a *Petition for Administrative Review*. Section (3) of the rule identifies what you must include in any petition as well as other requirements for a petition. WAC 480-07-825(4) states that any party may file an *Answer* to a Petition for review within (10) days after service of the petition.

WAC 480-07-830 provides that before the Commission enters a final order any party may file a petition to reopen a contested proceeding to permit receipt of evidence essential to a decision, but unavailable and not reasonably discoverable at the time of hearing, or for other good and sufficient cause. The Commission will not accept answers to a petition to reopen unless the Commission requests answers by written notice.

RCW 80.01.060(3), as amended in the 2006 legislative session, provides that an initial order will become final without further Commission action if no party seeks administrative review of the initial order and if the Commission fails to exercise administrative review on its own motion.

You must serve on each party of record one copy of any Petition or Answer filed with the commission, including proof of service as required by WAC 480-07-150(8) and (9). To file a Petition or Answer with the Commission, you must file an original and **three (3)** copies of your Petition or Answer by mail delivery to:

The Utilities and Transportation Commission has information that you are conducting household goods moves within the state of Washington. Advertisements for your household goods services have been found on www.pickupandmove.com, www.tacomamovers.net, www.thumbtack.com, www.movinghelp.com, www.angieslist.com, www.yelp.com, www.hireahelper.com, and www.facebook.com. You do not have a valid permit, as required by state law, to conduct this type of work. Conducting household goods moves requires a permit issued by the commission.

To avoid enforcement action, your complete household goods permit application, supporting materials, and application fee must be submitted to the commission by **July 13, 2017**.

Until you obtain a permit, you must immediately cease operating as a household goods mover in Washington State. Operating as a household goods mover without the required permit is illegal and subject to a penalty of **\$5,000 per violation**. This means that you may receive this penalty for each day you operate in violation of the law.

You must also immediately cease advertising as a household goods mover in Washington State. Advertising for the transportation of property for compensation in Washington without a proper permit is against the law. The penalty for advertising without a permit is **\$5,000 per violation**. This means that you may receive a penalty for each and every advertisement. At this time, the commission has documented advertisements for household goods moving services from Man and a Van, Inc. aka The Wright Movers, Tacoma Movers, and Pick Up & Move.

If you advertise or operate as a household goods mover without a permit, the commission will take enforcement action against you. Such action may include the above-mentioned financial penalties, and you will be served with a subpoena and be required to appear before a judge.

Again, to avoid enforcement action, your complete application, supporting materials, and application fee must be submitted to the commission by **July 13, 2017**.

(Man and a Van or Applicant) filed an application with the Washington Utilities and Transportation Commission (Commission) for authority to operate as a household goods carrier in the state of Washington (Application). Anthony Wright, the company's owner, submitted and signed the Application.

On June 29, 2017, the Commission issued a Notice of Intent to Deny Application for Permanent Authority; Notice of Opportunity for Hearing. On June 30, 2017, Mr. Wright contacted the Commission and requested a hearing.

On July 6, 2017, the Commission issued a Notice of Brief Adjudicate Proceeding; Setting Time for Oral Statements. The Notice scheduled a brief adjudicative proceeding (BAP) for August 2, 2017. The BAP was later rescheduled for August 8, 2017, at Commission staff's (Staff) request.

On August 7, 2017, Mr. Wright contacted the Commission and requested the BAP be continued for another 30 days. Staff supports the Applicant's request, but is unable to propose a new date due to the unavailability of key personnel. Staff agreed to confer with the Applicant and submit proposed dates to the presiding administrative law judge later this week.

The Commission finds good cause to cancel the BAP scheduled for August 8, 2017, and to suspend the procedural schedule until such time the parties are able to confer and propose a new date and time.

THE COMMISSION GIVES NOTICE That the brief adjudicative proceeding set for August 8, 2017, at 9:30 a.m. in Docket TV-170284 is cancelled, and the procedural schedule is suspended until further notice.
