Dear Mr. King:

The Directors of Shirona Water Company LLC have purchased a second water system and at the Directors have changed the page 1 pow owns. now owns and manages both water systems. Shirona and Crosswoods are both regulated under the Utilities and Transportation Commission (UTC) jurisdiction. The Directors have also submitted a rate case package for a modest cost of living increase. The UTC has requested the rate case filing combine both systems with the same new billing rate. This notification includes information concerning a combined rate case filling with the UTC.

Following a review of the system operations cost and maintenance, the Directors have come to the conclusion that a modest increase in rates is needed. We have tried to keep the cost of the systems operation and water treatment as low as possible, but find that State regulation and an aging system have brought us to where we are now. The last rate increase to the Shirona system was in October of 2016. We have requested a 4% cost of living increase at this time. If accepted, this means that the all customers would have a new monthly base rate of \$28.60. This is an increase of \$8.35 to the Crosswoods base rate. The rate case will be determined and regulated by the UTC commission effective July 29, 2018.

Acceptance of a rate case will involve this billing rate increase to cover repair & expenses in the year 2017 and through 2018. King Water will still manage testing, maintenance, repairs, and billing for both systems. Existing Tariffs for Shirona and Crosswoods have been revised to reflect the combined rate case filing as requested by UTC staff.

Wildwood Water Company, LLC wishes to file its name change and rate case request. The rate case package has been assembled based upon expert guidance provided by UTC staff; Many thanks to staff members for the help. Attached are the following documents:
