#### TE180227 - Cancellation of Certificate CH067206 Due To Insufficient Proof of Insurance

Dear Latin Limousine LLC:

On February 9, 2018, the Washington Utilities and Transportation Commission (Commission) notified you that your transportation certificate would be canceled unless you submitted acceptable proof of insurance by March 13, 2018. Our records show that you failed to submit acceptable proof of insurance by that deadline. As a consequence, the Commission has CANCELED your certificate. You must immediately CEASE all operations associated with this certificate. If you advertise or operate without a valid certificate, the commission may take enforcement action against you.

You have the right to a hearing. If you believe the Commission should not have canceled your certificate, you may ask the Commission to schedule a hearing before an administrative law judge. At the hearing the only issue the Commission will address is whether you had proof of insurance on file to avoid cancellation. Email your request to Steven V. King, Secretary, at <a href="mailto:records@utc.wa.gov">records@utc.wa.gov</a>. You may also mail your request to 1300 S. Evergreen Park Drive. SW, PO Box 47250, Olympia, WA 98504-7250. The Commission must receive your request within 14 days after the date of this letter.

You may apply to reinstate your certificate. Download the reinstatement application at <a href="https://www.utc.wa.gov">www.utc.wa.gov</a>. To locate application instructions, type "File Your Transportation Application Electronically" in the site search bar, and select this link. Then, click on the appropriate industry application.

**Re: Passenger Transportation Services** 

Dear Mr. Rosales Barojas:

We have received information that Latin Limousine may be offering passenger transportation services that fall under the jurisdiction of the Washington Utilities and Transportation Commission (Commission).

According to your company website and Facebook page, Latin Limousine charter services. Latin Limousine's 16 and 22-passenger Hummers and 26-passenger party bus are passenger transportation services as defined in WAC 480-30-036(2) and require a certificate of authority issued by the Commission.

Operating as a passenger transportation company within Washington without the required certificate is illegal, is considered a gross misdemeanor, and is punishable as such (see RCW 81.70.220 and WAC 480-30-246). Until and unless the Commission grants your company the proper authority, you must remove any related advertising and cease offering and/or providing services subject to Commission regulation.

To avoid enforcement action by the Commission, no later than March 28th, 2016, you must either:

• Submit a completed application, file proof of insurance and include the application fee. For questions about the application process, please contact our Licensing Services staff at (360) 664-1222.

OR

• Explain in writing why you believe your business does not require a charter carrier certificate from the Commission. Please explain the nature of your company's operations in detail.
