DECLARATION OF JASON HOXIT

Jason Hoxit, under penalty of perjury under the laws of the State of Washington, declares as follows:

- 1. I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Consumer Protection Division. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility and transportation companies. As part of those duties, I investigate charter party and excursion service carriers that may be operating without the required Commission-issued certificate.
- 2. On November 13, 2013, Commission Compliance Investigator Betty Young sent A-Star Limousine LLC (A-Star Limousine or Company) an email stating that the Commission believed A-Star Limousine was "offering charter and excursion services on its website (http://www.a-starlimousine.com/)." On November 13, 2013, the Company responded to Commission staff stating, "The Max seating capacity is 14. No exceptions."
- 3. On September 20, 2018, Commission Compliance Investigator Michael Turcott sent A-Star Limousine a compliance letter to 816 W. Francis Ave #141, Spokane, WA 99205. The letter stated, "Both the 20-passenger stretch Hummer and the party bus featured on your website and Facebook page exceed the authority of your limousine license and require a charter certificate from the Commission."²
- 4. On October 3, 2018, A-Star Limousine responded to Commission staff stating, "I understand that we are limited to 14 passenger seating capacity under our current licensing and insurance requirements."

5. On January 11, 2019, I received a tip via email concerning a potential non-certificated charter party and excursion service carrier. The email stated that A-Star Limousine is operating a 20 passenger Hummer.

- 6. On January 11, 2019, I searched Commission records and found that A-Star Limousine is not a certificated charter party and excursion service carrier.⁴
- 7. On January 11, 2019, I located the Company's website, www.a-starlimousine.com. Under the "Spokane Limo Bus" tab, the website stated, "The Stretched Hummer seats 20, Has Aux and Bluetooth connections for music, Can rent for \$200 per hour or \$400 for Round trip service. Perfect for bachelor(ette) parties." The Company's website included the address of 816 W. Francis PMB #141, Spokane, WA 99205, and the telephone number of (509) 879-7948.
- 8. On January 11, 2019, I searched Washington Secretary of State's database, and Washington Department of Revenue's Business Licensing Service's database, which produced records showing A-Star Limousine in active status in the state of Washington. I found the governing person of Michelle Palm, and an address of 816 W. Francis Ave #141, Spokane, WA 99205. I also found that A-Star Limousine has an active limousine endorsement through Washington State Department of Licensing, which allows a limousine carrier to operate an automobile with a seating capacity behind the driver of no more than 14 passengers.
- 9. On January 28, 2019, I located A-Star Limousine's verified Facebook page. The Company's Facebook page included the address of 816 W. Francis Ave #141, Spokane, WA 99205, the telephone number of (509) 879-7948, and the website address of www.a-starlimousine.com.⁸
- 10. On January 28, 2019, I sent A-Star Limousine a message through its verified Facebook page under an assumed name. In the Facebook message I requested to book a trip for 16-18 passengers on June 15, 2019, for a bachelor party. A-Star Limousine responded to the inquiry on the same day stating, "Our stretch Hummer seats 20 and is the largest in our fleet. It's \$200 per hour and books up fast!" The Company confirmed that the telephone number to make the reservation is (509) 879-7948.9
