Amendment Number: 1

Description of amendment:

The Agreement is amended by adding terms and conditions for Unbundled Network Elements (UNEs) and Resale as set forth in attachments and Exhibit A to the Amendment.

The Amendment amends the Interconnection Agreement first accepted by the Commission on 8/16/2019 in WUTC Docket No. UT-190686. That Agreement was originally approved by the Commission on 2/6/2018 in WUTC Docket No. UT-180098 between Company A and Company C (Matrix Telecom, LLC dba Matrix Bus Technologies dba Trinsic Communications).


Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
