RE: Clarification of Commission Published Household Goods Tariff 15-C Docket TV-200809

TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) will publish revisions to Tariff 15-C (Household Goods) with a proposed effective date of November 1, 2020. The Commission will consider the tariff changes proposed by Commission staff (Staff) at its regularly scheduled open meeting on October 29, 2020. The proposed tariff changes does not revise current practice, rather they clarify:

- alternative pick up or delivery options are available as outlined in Item 15,
- hourly rates listed in Item 230 should be used for additional charges as a result of conditions listed in Item 15, 2(g) or 2(h), and
- carriers may conduct visual inspections for estimates using video conferencing options that allow the carrier to interact with the customer in real time.

One additional change corrects a rate error in Item 62. The maximum rate in the current tariff shows a lower rate than the minimum rate. This was missed when updating the rate table in docket TV-190664.

Proposed revisions to Tariff 15-C are reflected in Attachment 1: Cover Page; Page 2 containing Table of Contents; Page 7 containing Item 15 – Alternative Pick Up or Delivery Options, and Refusal To Provide service; Page 10 containing Item 62 – Appliance Service; and Page 13 containing Item 85 - Estimates. Revisions are noted in track changes.
