The purpose of this substitute filing is 1) to further clarify the reference to individual electric and natural gas benefit funding caps; 2) to remove the reference to the inclusion of grant distributions and education costs in the Cost Recovery section; and 3) to revise the Automatic CACAP Benefit Distribution Eligibility Criteria to allow PSE greater discretion as to how frequently it may automatically provide the CACAP benefit amount to qualifying residential service accounts. This substitute filing is being made based on the feedback PSE received from WUTC Staff. Additionally, this substitute filing adds clarifying language to the eligibility criteria and income guidelines.

The tariff sheets described herein reflect an issue date of February 26, 2021, and an effective date of March 28, 2021. Posting of the proposed tariff change for public inspection and review, as required by law and the Commission's rules and regulations, is being completed in accordance with WAC 480-100-193(1).
